# **RECITALS**

WHEREAS Client wishes to retain Tanks Data LLC to perform services for managing compliance of gas stations.

WHEREAS Tanks Data LLC wishes to perform these services in lieu of mutually agreed compensation listed below.

NOW THEREFORE, in consideration of the mutual benefits and promises, and other good and valuable consideration stated herein, Tanks Data LLC and Client hereby agree as follows:

# 1. Scope of Work

Managing compliance of gas station(s) listed in "Annexure I," subject to timely supply of all required paperwork/documents and timely response to all other required questions in this regard, within stipulated time frame. Managing compliance does not include any work which requires any certification or licensing including any environmental certification. Client(s) signing this contract agree to provide all paperwork within 2 days of making the request of required documents by email/phone and immediate response to all other required testing/repair needs.

# 2. Compensation

Client agrees to pay and authorize Tanks Data LLC to charge \$\_125\_ per month per facility for the list of facilities provided in "Annexure I" in consideration of services to the Client, effective from the signing of this contract, until the cancellation of this contract by any party by giving 10 days written notice without any obligation.

#### 3. Confidential Information

Confidential Information means any current or future technical and non-technical information related to the Company's business. Except as permitted in this Section, Client shall not use, disseminate or in any way disclose Confidential Information.

#### 4. Term and Termination

Time is of the essence in the provision of services under this Agreement. This Agreement shall be effective as of the date of signature by the parties and remains in full force until the cancellation by any party by giving 10 days written notice.

### 5. Governing Law

This Agreement shall be governed under the laws in the State of Indiana.

#### 6. Indemnification

The Client shall indemnify and hold Tanks Data LLC, Tanks Data Maintenance Services Inc., its members, managers and officers, and its agents and employees, and affiliates harmless from any and all claims, causes of action, losses, damage, liabilities, costs, and expenses, including reasonable attorney fees, arising from the death of or injury to any person, from damage to or destruction of property, or from breach of the warranties in this Section, arising from the provision of services by Tanks Data LLC, Tanks Data Maintenance Services Inc., its agents or employees under this Contract.

#### 7. Severability

This Agreement shall remain in effect in the event a section or provision is unenforceable or invalid. All remaining sections and provisions shall be deemed legally binding unless a court rules -

that any such provision or section is invalid or unenforceable, thus limiting the effect of another provision or section. In such a case, the affected provision or section shall be enforced as so limited.

The total liability in any case for any reason whatsoever arising out of the performance/nonperformance of services shall not exceed \$100, which shall be complete and exclusive.

# 10. Final Agreement

It is agreed between the parties that there are no other agreements or understandings between them relating to the subject matter of this Agreement. This Agreement supersedes all prior agreements, oral or written, between the parties and is intended as a complete and exclusive statement of the agreement between the parties. No change or modification of this Agreement shall be valid unless the same be in writing and signed by the parties.

#### 11. Arbitration

- In case of breach of this contract by any party to this contract, no party shall been titled to any damage or loss or costs or expenses.
- Alternate Dispute Resolution: Parties to this contract shall honestly try to resolve any dispute arising out of this contract by negotiations among them or by calling a mediator.

The total liability in any case for any reason whatsoever arising out of the performance/nonperformance of services shall not exceed \$100, which shall be complete and exclusive.
- The client shall provide reasonable access to his premises for performing the said service under this contract.
